### **INSTRUCTION TO BIDDER / TENDERER**

1. The Bidder is expected to examine all instructions, forms, terms, and specifications in the Bidding Documents, Failure to furnish all information or authentic documentation required by the Bidding Document may result in rejection of the Bid.
2. Tender Bid can be sent by post/ courier or submitted by hand at our office by time as specified in tender notice. Tenders received late will be rejected.
3. For bids submitted by post or Courier, it is the bidder's responsibility that bid reaches our office on or before the scheduled time and date.
4. In case tender opening date is declared a Holiday, bids shall be opened on next working day at the same time specified in tender.
5. The unit rates and the prices shall be quoted by the Bidder entirely in Indian Rupees unless otherwise specified in Bidding/ Tender document in case of International Competitive Bidding (ICB).
6. To establish their eligibility, Bidders shall complete the eligibility criteria specified / requested in the Bid/ Tender document.
7. To establish the conformity of the Goods and related Services to the Bidding Document, the Bidder shall furnish as part of its Bid, the documentary evidence (specifications, designs and drawings and others), supply samples where asked for, demonstrate trials or carry out tests as specified in Bidding /tender document.
8. Any attempt by a Bidder to influence the Procuring Entity "Bihar State Milk Co-operative Federation Ltd. (COMFED)" in the examination, evaluation, comparison, and post qualification of the Bids or Contract award decisions may result in the rejection of its Bid, in addition to the legal action which may be taken by the Procuring Entity under the Act and the Rules.
9. Information relating to the examination, evaluation, comparison, and post- qualification of the Bids, and recommendation of contract award, shall not be disclosed to Bidders or any other person not officially concerned with such process until information on Contract award is communicated to all Bidders.
10. To assist in the examination, evaluation, comparison, and qualification of the Bids, the Bid evaluation committee may, at its discretion, ask any Bidder for a clarification regarding its Bid. For clarification, the response of the Bidder shall be in writing.
11. Any clarification submitted by a Bidder with regard to his Bid that is not in response to a request by the Bid evaluation committee shall not be considered.
12. COMFED reserves the right to accept or reject any Bid, and to annul the Bidding process and reject all Bids at any time prior to Contract award without assigning any reasons thereof and without thereby incurring any liability to the Bidders.
13. COMFED shall award the contract to the Bidder whose offer has been determined to be the lowest in accordance with the evaluation criteria set out in Evaluation and Qualification Criteria and if the Bidder has been determined to be qualified to perform the contract satisfactorily.

## बोलीदाता / निविदाकर्ता के लिए निर्देश :-

1. निविदाकर्ता से सभी निर्देशों, प्रपत्रों, शर्तों एवं स्पेशिफिकेशन की जाँच करने की अपेक्षा की जाती है। सभी आवश्यक जानकारी या प्रमाणिक दस्तावेज प्रस्तुत करने में विफल बीड को अस्वीकार किया जा सकता है।
2. निविदा बीड डाक/कूरियर द्वारा भेजा जा सकता है या कार्यालय में जाकर समय रहते हाथो-हाथ जमा किया जा सकता है। विलम्ब से प्राप्त निविदाओं को अस्वीकार कर दिया जायेगा।
3. डाक या कूरियर द्वारा भेजा गया निविदा हमारे कार्यालय में निर्धारित तिथि व समय पर या उससे पहले पहुँचे इसकी जिम्मेवरी निविदाकर्ता की होगी।
4. यदि निविदा खोलने की तिथि को अवकाश घोषित किया जाता है तो निविदा अगले कार्य दिवस को उसी निर्धारित समय पर खोली जायेगी।
5. निविदाकर्ता द्वारा अंकित इकाई दर एवं कीमत पूरी तरह से भारतीय रुपये में होना चाहिए जब तक की अन्यथा निविदा दस्तावेज में यह प्रदर्शित न हो जैसे कि अन्तरराष्ट्रीय प्रतिस्पर्धी बोली में होता है।
6. अपनी प्रात्रता स्थापित करने के लिए निविदादाता को निविदा दस्तावेज में निर्दिष्ट/अनुरोधित प्रात्रता मापदंड को पुरा करना होगा।
7. निविदा दस्तावेज के लिए माल एवं संबंधित सेवाओं की अनुरूपता स्थापित करने के लिए निविदादाता को अपनी बीड के अंश के रूप में साक्ष्य दस्तावेज (स्पेशिफिकेशन, डिजाइन, ड्राइंग इत्यादि) माँगे गए नमूने प्रस्तुत करना, ट्रायल प्रदर्शन करना अथवा सामग्री का परीक्षण करना होगा जैसा कि निविदा दस्तावेज में निर्दिष्ट है।
8. किसी भी निविदादाता द्वारा क्रय इकाई "बिहार राज्य दुग्ध सहकारी संघ (कॉम्फेड)" को बीड के परीक्षण, मूल्यांकन, तुलना एवं योग्यता के उपरान्त बीड या अनुबंध निर्गत निर्णय में प्रभावित करने का कोई भी प्रयास जिसमें अधिनियम एवं नियम के तहत कानूनी प्रक्रिया शामिल हो, बीड को रद्द कर सकता है।
9. परीक्षा, मूल्यांकन, तुलना के उपरान्त योग्य बीड तथ अनुबंध पुरस्कार की सिफारिश से संबंधित सूचना निविदादाता या ऐसे अन्य व्यक्ति जो अधिकारिक तौर पर ऐसी प्रक्रिया से संबंधित नहीं हो को नहीं दी जायेगी जबतक कि सभी निविदादाताओं को अनुबंध पुरस्कार की सूचना नहीं दी जाती है।
10. बीड परीक्षण, मूल्यांकन, तुलना एवं योग्यता में सहायता हेतु बीड मूल्यांकन समिति अपने विवेक से किसी भी निविदादाता से उसकी बीड के संबंध में स्पष्टीकरण माँग सकती है। स्पष्टीकरण के लिए निविदादाता की प्रतिक्रिया लिखित में होगी।
11. किसी निविदादाता द्वारा अपनी बीड के संबंध में प्रस्तुत किया गया कोई भी स्पष्टीकरण जो किसी अनुरोध के जवाब में नहीं है, बीड मूल्यांकन समिति द्वारा विचार नहीं किया जाएगा।
12. कॉम्फेड किसी भी बीड को स्वीकार या अस्वीकार करने और बीड प्रक्रिया को रद्द करने का अधिकार सुरक्षित रखता है। सारे बीड को बिना कोई कारण बताए अनुबंध देने से पूर्व किसी भी समय एवं निविदादाता का कोई भी दायित्व वहन किए बिना रद्द किया जा सकता है।
13. कॉम्फेड उन निविदादाता को अनुबंध प्रदान करेगा जिसका प्रस्ताव निर्धारित मूल्यांकन और योग्यता मानदंडों के अनुसार न्यूनतम हो एवं निविदादाता अनुबंध को संतोषजनक ढंग से करने के लिए संकल्पित हो।

Bids received shall be evaluated as per the criteria prescribed in the tender document. COMFED/ Unions will not entertain any modification subsequent to opening of bids and bids not conforming to tender conditions shall be liable to be rejected. Therefore, bidders are advised to submit their bids complete in all respect as per the requirement of tender document specifying their acceptance to all the clauses of Bid Evaluation criteria, General terms and conditions and compliance to the schedule of supply etc.

Any corrigendum, updates etc. relating to this tender will be published only in our web site and not in any other media including newspaper. Therefore, interested bidders may regularly visit our website or contact the undersigned.

सीलबंद बीड/प्रस्ताव दिनांक 06.07.2022 को (रविवार एवं अवकाश को छोड़कर) हमारे कार्यालय में पूर्वाह्न 11:00 बजे आपूर्तिकर्ता या उनके प्रतिनिधि जो शामिल होना चाहते हो के समक्ष खोली जाएगी। प्राप्त बीड का मूल्यांकन निविदा दस्तावेज में निर्धारित मानदंड के अनुसार किया जाएगा।

कॉम्फेड/संघ बीड खोलने के उपरान्त किसी भी संशोधन पर विचार नहीं करेंगे तथा निविदा शर्तों के अनुरूप नहीं होने पर खारिज कर दिया जाएगा। इसलिए निविदादाताओं को सलाह दी जाती है कि वे बीड को पूर्ण रूप से संतुष्ट होकर निविदा दस्तावेज के आवश्यकता अनुसार बीड मूल्यांकन मानदंड, समान्य नियम व शर्तों और आपूर्ति की अनुसूची के अनुपालन के सभी खंडों के लिए अपनी सहमति देते हुए जमा करना सुनिश्चित करेंगे।

## **DETAILED TERMS AND CONDITIONS OF THE TENDER DOCUMENT**

1. Brokers shall indicate the name & address of the supplier of raw materials and this shall be accompanied with sample of materials. Brokerage will be paid @ Rs.10.00 (Rupees ten) only per MT or 1% of the cost of the ordered, supplied quantity whichever is less.
2. The rates quoted by concerned suppliers shall be valid at least **up to 31.07.2022** and they will have to supply the material at the quoted rate as per ordered specification and as per the delivery schedule stipulated in the purchase order.
3. Parties may send free samples of the above items as per our specification along-with the offer.
4. Rates shall be quoted on FOR cattle feed plant and on gross weight basis as per enclosed format for different raw materials. For Molasses and Vitamins premix, net weight would be considered.
5. Bidder submitting the rate for less than 50% of the tendered quantity of materials shall not be considered.
6. The new tenderers must indicate their GST, PAN registration nos. in the offer, failing which the offer of the party will be summarily rejected. Applicable taxes (if any) must be specifically indicated in the offer even if the net offered rate is tax paid. All statutory liability of taxes, duties shall be of the suppliers and shall be borne by them within the rate offered.
7. The quantity required as mentioned in Annexure I may be changed based on availability of raw materials and its rate.
8. COMFED/ Unions at its sole discretion may distribute the order quantity to more than one supplier without assigning any reason to any of the successful bidder during issuance of order after discussion with relevant eligible suppliers. The splitting of the tender/ Purchase quantity will be made on the following manner:  
L1 bidder : 70% of the ordered quantity  
L2 bidder : 30% of the ordered quantity  
However, if the L1 bidder quoted the rate for restricted quantity, then COMFED/ Unions may distribute the rest quantity to L2 or L3 bidder based on L1 rate.
9. The excess/ less quantity up to  $\pm 10\%$  or maximum one truck load whichever is less shall be acceptable. But such relaxation would be under full discretion of Purchaser only.
10. Our payment terms shall be 75% within ten days of receipt of materials along with invoice & on physical verification and balance 25% on receipt of test report. All payment will be made from concerned cattle feed plants.
11. The weighment of material shall be carried out at Cattle feed plant or as arranged by the Purchaser. The weight of the materials so received will be treated as final and binding to the supplier.
12. Material to be suitably packed to prevent damages or any pilferages during transit. The goods packed in torn or unsound condition of bags may be rejected or may face proportionate deduction.
13. The materials to be delivered strictly as per prescribed specification. In case of deviation, COMFED/ Union reserves full right either to accept the goods after imposing additional rebate beyond acceptable guidelines in accordance to the consent of supplier or issue directive to the supplier to lift the rejected goods after intimation either through letter/ mail or telephonic intimation too. In carrying out above task of either rejection or accepting the commodity with additional rebate, this should not demand any clarification or explanation from the supplier in subsequent period and the decision on above exercise adopted by COMFED / Union would be final and binding to the supplier. Beyond the stipulated lifting time limit of 15 days from information to lift the materials, the rejected goods would be disposed of as per discretion of COMFED / Union and no correspondence on same would be entertained. The cost of disposal would be recovered from the supplier account. Payments are likely to be held up if quality of the material found to be substandard.

14. Late delivery penalty: COMFED /Union will have full discretion to receive the item and honour the order beyond the schedule date of delivery subject to prior approval from the Purchaser. In case the material is accepted after schedule date, the penalty will be imposed @1% of the total supply value for first 15 days and 2% up to 30 days after the due delivery date. The delivery of item beyond that needs further approval from Purchaser only.

15.COMFED/ Union reserves the right to purchase the materials at the risk cost and responsibility of the supplier in case of non-supplies or short supplies. All expenses including payment in risk purchase shall be adjusted against the security deposit or shall be recovered from the pending bills of the supplier. Alternatively, it shall be recovered from them through legal action also.

16.COMFED/ Union reserves the right to reject any or all the offers without assigning any reason thereof. In the event of any dispute between the Parties, both the parties mutually resolve such disputes, failure of which, such dispute shall be referred to arbitrator to be appointed in accordance with the provisions of Indian Arbitration Act, 1996. The Arbitration proceeding will have to be held at Patna or such other place as decided by the Arbitrator at his discretion. The order/ decision of arbitrator shall be final and will be accepted by both the parties.

## निविदा दस्तावेज के विस्तृत नियम और शर्तें

1. ब्रोकर कच्चे माल के आपूर्तिकर्ता के नाम और पते का उल्लेख करेंगे एवं इसके साथ सामग्री का नमूना भी संलग्न करेंगे। ब्रोकरेज का भुगतान 10.00 प्रति मै0 टन या आर्डर की गई मात्रा की लागत का 1 प्रतिशत जो भी कम हो, का भुगतान किया जाएगा।
2. संबंधित आपूर्तिकर्ताओं द्वारा उद्घृत दर कम से कम 31.07.2022 तक मान्य होगी और उन्हें आदेशित स्पेशिफिकेशन के अनुसार और क्रय आदेश में निर्धारित वितरण कार्यक्रम के अनुसार उद्घृत दर पर सामग्री की आपूर्ति करनी होगी।
3. पार्टियों हमारे स्पेशिफिकेशन के अनुसार उपरोक्त मदों के निःशुल्क नमूने प्रस्तुत दर के साथ भेज सकती है।
4. दर पशु आहार संयंत्र तक पहुँचाकर (एफ.ओ.आर) एवं सकल वजन (ग्रॉस वजन) के आधार पर प्रस्तुत करना होगा। छोआ और विटामिन प्रीमिक्स के लिए शुद्ध वजन (नेट वजन) मान्य होगा।
5. सामग्री की निविदा मात्रा के 50 प्रतिशत से कम के लिए दर जमा करने वाले निविदादाता पर विचार नहीं किया जाएगा।
6. नये निविदाकारों को अपने जी.एस.टी., पैन पंजीकरण संख्या का उल्लेख प्रस्तावित दर के साथ करना होगा अन्यथा पार्टी के द्वारा प्रस्तुत दर को सरसरी तौर पर खारिज कर दिया जायेगा। लागू कर (यदि कोई हो) को विशेष रूप से ऑफर दर में दर्शाया होगा चाहिए भले ही शुद्ध प्रस्तावित दर कर का भुगतान किया हो। करो, कत्तव्यों के सभी वैधानिक दायित्व आपूर्तिकर्ता के होंगे और उनके द्वारा प्रस्तावित दर के अन्दर वहन किया जाएगा।
7. अनुलग्नक 1 में उल्लेखित अपेक्षित मात्रा को कच्चे माल की उपलब्धता एवं इसके दर के आधार पर बदला जा सकता है।
8. कॉम्पेड/संघ अपने विवेकाधिकार का प्रयोग करते हुए किसी भी सफल बोलीदाता को बिना कारण बताए योग्य आपूर्तिकर्ताओं से विचार के उपरान्त आदेशित मात्रा को एक से अधिक आपूर्तिकर्ता के बीच वितरण कर सकता है। निविदा/क्रय मात्रा का बटवारा निम्नलिखित आधार पर किया जा सकता है।  
L1 बोलीदाता – आदेशित मात्रा का 70%  
L2 बोलीदाता – आदेशित मात्रा का 30%  
हालांकि यदि L1 बोलीदाता ने प्रतिबंधित मात्रा के लिए दर प्रस्तुत किया है तो कॉम्पेड/संघ शेष मात्रा का L1 दर पर L2 या L3 निविदादाता को आवंटित कर सकता है।
9. आपूर्तिकर्ता द्वारा आपूर्तित अधिक/कम मात्रा  $\pm 10\%$  या अधिकतम एक ट्रक लोड जो भी कम हो स्वीकार्य होगा लेकिन ऐसा छूट केवल क्रेता का पूर्ण विवेक पर निर्भर करेगा।
10. हमारी भुगतान शर्तों के अनुसार 75% भुगतान टैक्स बिल एवं सामग्री प्राप्ति के दस दिनों की भीतर भौतिक सत्यापन के उपरान्त की जाएगी। शेष 25% भुगतान जाँच रिपोर्ट प्राप्ति के उपरान्त होगा। ये सभी भुगतान संबंधित पशु आहार संयंत्र द्वारा किया जायेगा।
11. सामग्री का वजन पशु आहार संयंत्र में अथवा उनके द्वारा व्यवस्थित किया जायेगा। इसके उपरान्त प्राप्त सामग्री का वजन अंतिम मान्य होगा और आपूर्तिकर्ता के लिए बाध्यकारी होगा।
12. परिवहन के दौरान नुकसान या किसी भी चोरी को रोकने के लिए सामग्री को उपयुक्त रूप से पैक किया जाना चाहिए। फटे या खराब स्थिति में पैक किए गए बैग को अस्वीकार किया जा सकता है या अनुपातिक कटौती के साथ स्वीकार किया जा सकता है।
